



An important update to your GLP-1 medication access requires your action. Eligible National IAM Benefit Trust Fund participants who currently may be prescribed a GLP-1 medication for weight loss (Wegovy or Saxenda) are required to enroll in Virta by 3/31/2026 to maintain coverage of this medication through the National IAM Benefit Trust Fund. This process includes a video appointment with a Virta provider and can take one to three weeks.

When you join Virta, you'll:

- Continue GLP-1 coverage if you and your Virta provider determine it's right for you
- Work closely with your Virta care team to safely adjust medications when the time is right
- Explore nutrition-based approaches that may reduce or replace the need for medication

National IAM Benefit Trust Fund partners with Virta to support your weight loss journey—with or without medications. Virta is a nutrition-first program that helps you lose weight and improve your health, available at \$0 cost to you.* With personalized nutrition plans and expert support, Virta helps you build healthy habits for long-term success.

Please note: If you fill your prescription through a provider outside of Virta after 3/31/2026, you will be responsible for the full cost out-of-pocket. **Take action and enroll in Virta by 3/31/2026**, to ensure you can maintain GLP-1 coverage, if recommended and eligible, and gain access to Virta's care for long-term success. After 3/31/2026, prescriptions filled outside of Virta will not be covered by the National IAM Benefit Trust Fund.
